Enrollment Contract 2011 - 2012

I elect, agree and contract to pay tuition and any applicable fees for my child/children as listed in this contract for the 2011-2012 school year. Enclosed is the non-refundable enrollment fees of \$100.00 per student if paid by June 30, 2011; \$125.00 per student if paid after June 30, 2011.

I hereby agree that in case of default in payment of any tuition/fees, the entire unpaid balance of this debt shall, at the option of The Ashford Academy administration and/or Board of Directors, become immediately due and payable. I hereby agree to pay all costs of collecting, or attempting to collect or secure, tuition or fees due, including a reasonable attorney's fee, whether the same is collected or is secured by litigation or otherwise. I further understand this instrument will be interpreted in accordance with the laws of the State of Alabama.

I understand and agree that my obligation to pay tuition/fees for the full academic year or portion of the year after the date of enrollment is unconditional unless the child/children are withdrawn, in writing, prior to June 15, 2011. I understand and agree to pay a \$500.00 per child withdrawal fee upon withdrawal of my child/children after June 15, 2011. I further understand that if I withdraw my child/children after classes have begun, that I will be responsible for a \$500.00 per child withdrawal fee plus all book fees, building and maintenance fees and tuition for the remainder of the semester (or 9 weeks), and any other outstanding debt that is due Ashford Academy. *In the case of a bona fide hardship (job loss, serious illness, etc.) or bona fide move whereby students are living at such a distance so as to cause genuine hardship with regard to daily transportation – the board may agree to relieve in part or whole, financial obligations specified in the enrollment contract.*

By signing this contract, I obligate myself for the entire tuition/fees amount specified above. I understand tuition paid monthly is due by the 1st of each month and must be received no later than the 10th of each month. Annual payments are due August 1st and must be received before the 10th of August. I also understand that when any payment is in arrears; a \$25.00 late fee will be levied each month thereafter, grades/report cards will not be issued, transcripts or records will not be released, participation in extracurricular activities will not be allowed, and the child/children will not be accepted or renewed to the following school term. Any tuition accounts that reach 15 days in arrearage may result in dismissal of the student or legal action. Participation in summer extracurricular activities will not be allowed until registration is complete and all financial obligations from the previous school year are paid in full.

The child/children's continued enrollment in Ashford Academy will be contingent upon the student's and the parent's /guardian's compliance with the policies and rules of the school as specified in the Student Handbook. The undersigned agrees to accept the rules, regulations, and policies of Ashford Academy and to support the educational, philosophy, moral, dress, attendance, disciplinary, internet, and other standards of Ashford Academy as stated in the Student Handbook and other school publications. Failure to support the standards of the school by the undersigned may result in dismissal of the student. The undersigned further agrees that this enrollment is contingent on the student's successful completion of the previous academic year at the current school based on prevailing academic and disciplinary criteria as determined by Ashford Academy administration.

Ashford Academy retains the right to use any photography and video of school activities and students (both candid and pre-arranged) for promotional, publicity, advertising, and marketing purposes. No additional notification is deemed necessary with the signing of this contract. By signing this contract, I also agree to allow the school to publish my names, address, and telephone number in the school directory.

I affirm that I am the parent or legal guardian of the listed child/children and said child/children resides in my household. I understand as the parent or legal guardian of the listed child/children that I am responsible for the fulfillment of any financial obligations even though another individual is providing payment or partial payment for the tuition.
